


to work but have not yet secured employment here. This change has not been applied to counts of employed nurses for past years.

³ Outflow refers to the number of registrants who registered in the previous year who did not register in the current year.

⁴ New Registrants is anyone who have never registered with the College.

⁵ International new registrants are those who have a) registered with NSCN for the first time and


b) identified an institution outside of Canada as the place where they received their initial nursing education. While they may have previous nursing experience internationally, they are categorized as new graduates in


this profile if they have taken additional bridging education to obtain licensure in Nova Scotia.


